## Commonwealth Bank of Australia "Flight Centre Gift Card November 2017" Promotion Conditions of Entry

- Information on how to enter and prize details set out in all communications regarding the Commonwealth Bank of Australia "Flight Centre Gift Card November 2017" Promotion (the "Promotion") form part of these Conditions of Entry. Any entry that does not comply with these Conditions of Entry will be deemed invalid. Entry into this Promotion and acceptance or receipt of a prize by a winner is deemed as acceptance of these Conditions of Entry.

- 3. This Promotion commences at 9:00am AEDST on 6 November 2017 and closes at 11:59pm AEDST on 3 December 2017 (the "**Promotion Period**").

"Eligible Flight Centre Gift Cards" include Flight Centre mail gift cards to the value of \$50, \$100, \$250, \$500, or \$1000, and Flight Centre email gift cards to the value of \$50, \$100, \$250, \$500, \$1000.

- 7. There will be one (1) draw conducted for this promotion. The draw will be conducted by a computerised drawing system at 3:00pm AEDST on 12 January 2018 by a representative of Anisimoff Legal, 5/210 Central Coast Hwy, Erina NSW 2250 on behalf of the Promoter. Anisimoff Legal may draw additional entries and record them in order in case an invalid entry or ineligible entrant is drawn.
- 8. The winners will be notified by telephone and mail or email within two (2) business days of the draw date and their names will be published in The Australian on 19 January 2018.

- 9. The first five (5) valid entries drawn will win an AU\$1,000 Flight Centre gift card. The Flight Centre gift card will be valid for 12 months from date of issue and is redeemable at Flight Centre retail stores within Australia only.
